3 "Amount of loss through non-payment" means the amount of national taxes for which tax liabilities were revoked for the reasons of elapse of three years after the suspension of procedure for collection of tax delinquency, completion of extinctive prescription, and so on.

4 "Amount of unsettled collection" means the part of amount determined for collection for which receiving, loss through non-payment is not completed.

Note: 1 Figures for "Inheritance tax" includes the gift tax.

2 "Internal local consumption tax" means the local consumption tax part of the amount of "consumption tax and local consumption tax."

3 "Excluded local consumption tax" means the amount of local consumption tax excluded from the "total amount."

4 Figures only for National tax agency are shown. Figures for customhouse are not included.
